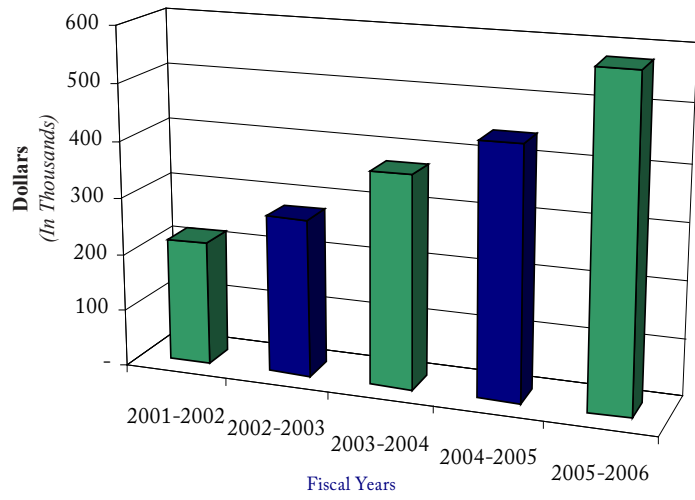

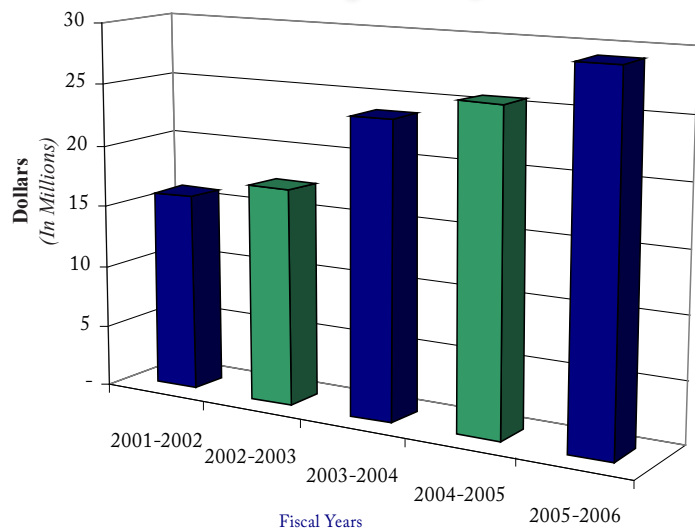

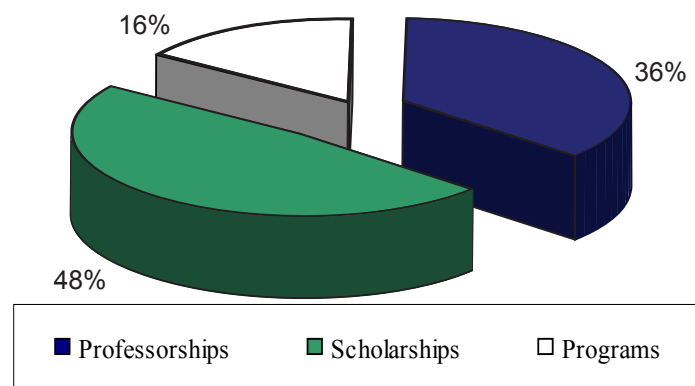
### Growth of the Endowment Over the Past Five Years
